

## BCR December IB Reward (BVI REGION ONLY)

### Participation Terms and Conditions:

- The promotion period is from December 1 to December 31, 2025.
- The valid deposit amount and trading volume of clients under the IB's name during the promotion period will be counted under the direct IB.
