

IB New Client Acquisition Reward

Terms and Conditions of Participation:

- The activity period ("Activity") is from September 1, 2026 to September 30 , 2026 .
- Only authorized IBs in the BCR GLOBAL BVI region are eligible to participate ; IBs in the SEA region are not eligible.
- BCRGLOBAL BVI overseas offices are not eligible to participate in this event.
